How we use your information

Log Files

Solutions Adda follows a standard procedure for using log files. These files log visitors' visits to websites. All hosting companies do this, and it is part of hosting services' analytics. The information collected by log files includes internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movements on the website, and gathering demographic information.
